


All employees of the State of Georgia to take an oath that they will support the Constitution of the United States and the Constitution of the State of Georgia. O.C.G.A. 45-3-11

Any public officer who willfully and intentionally violates the terms of his oath as prescribed by law shall, upon conviction thereof, be punished by imprisonment for not less than one nor more than five years O.C.G.A. 16-10-1

Offenses involving public records, documents, and other items O.C.G.A. 45-10-1

Establishment and text of code of ethics for government service generally O.C.G.A. 45-11-1



Applicable Law:

Theft by deception O.C.G.A. 16-8-2

- a. A person commits the offense of theft by deception when he obtains property by any deceitful means or artful practice with the intention of depriving the owner of the property.
- b. A person deceives if he intentionally:
 - 1. Creates or confirms another's impression of an existing fact or past event which is false and which the accused knows or believes to be false (the recount audits were flawed);
 - 2. Fails to correct a false impression of an existing fact or past event which he has previously created or confirmed (it's been proven there was ballot harvesting in 2020;
 - 3. Prevents another from acquiring information pertinent to the disposition of the property involved (no one can examine ballots from previous elections);

A Georgia Senate Sub-committee was formed to examine the 2020 election. The report was issued by Senator William Ligon (former judge for 16 years) in Brunswick, GA (ref 01)

Finding #9 stated <u>"</u>*The oral testimonies of witnesses on December* 3, 2020, and subsequently, the written testimonies submitted by many others, provide ample evidence that the 2020 Georgia General Election was so compromised by systemic irregularities and voter fraud that it should not be certified." (ref 01)

Coovert interviewed Senator Ligon and asked, "what did the SoS do about the facts in your report, he stated, "*He (SoS) did nothing*". (§16-08-2, § 45-11-1, § 45-10-1, § 45-3-11) **On December 22, 2020,** (just 5 days after the Ligon Senate Report was issued)

Statements from Raffensperger in his Letter to Congress January 6, 2021

42 Lies to the U.S. Congress

On January 6, 2021, just two weeks after *coordinating a whole of government effort.* Secretary Raffensperger sent a letter to the United States Congress and then Vicepresident Pence. In the 10 page document Secretary Raffensperger told the U.S. Congress, *"that no fraud or irregularities occurred at all in Georgia."* This document was not made public for months. (ref 8)

ONE OF MANY ALLEGATIONS INVOLVING DOMINION VOTING SYSTEMS

- "A third-party conducted an audit of voting machines in Ware County, Georgia and had found that the machines "flipped" votes from Trump to Biden at a rate of 28%. Not a single part of that rumor was true."
- Certified Ware County election results from the SOS office reported that Trump received 9865 votes, Biden received 4211 votes and Jorgenson received 136 votes in the 2020 General election. Published audit results for Ware County confirmed that Donald Trump actually received 9902 votes, Biden received 4174 votes and Jo Jorgenson received 117 votes.
- Brad Raffensperger's False Election Claims
- The hand count audit revealed the Dominion voting system recorded 37 more votes for Biden and 37 less votes for Donald Trump than the actual, verifiable audit totals.
- The rate is about .25% or almost exactly the victory margin rate that Joe Biden received over Donald Trump. The SOS office admitted in a press release that the audit found 37 more votes for Donald Trump than the voting system originally reported but did not acknowledge that the audit found that the system originally attributed those 37 extra votes to Joe Biden.

Fulton County Presidential audit contained

- A 60% batch error rate;
- 7 falsified tally sheets with 850 to 0 Biden votes;
- Over 200 duplicate scanned ballots;
- Over 4,000 duplicate reported ballots among other problems.
- Furthermore, tally sheets for over 50,000 Fulton and Cobb. Co. ballots were added to the audit roughly two months after it was conducted.

Further evidence a Pro V&V audit did not take place in Georgia. The Georgia report does not identify where the audits took place. The Georgia audit report does not list the audited machines serial numbers or seal numbers which is imperative in order to ensure the machines were not tampered with and allows the machines to be traceable. The Georgia audit report does not list the software verification serial and seal numbers to ensure proper software and no tampering. Tables from the Pro V&V report for Maricopa County, Arizona clearly identifying the actual machines, software, and seals.

Why is the Pro V&V Audit So Important

- Per State Law, every election in Georgia using the Dominion machines could be made invalid. See Moncla / Cross to State Election Board.
- Designed to persuade VP Pence and members of Congress there was no fraud in Georgia.
- The audit was used to convince Georgia citizens of the same.
- Law makers in Georgia used the audit in making decisions to changes to election laws and whether to continue the use of Dominion machines.
- The audit was used in convincing the Georgia Inspector General Scott McAfee there was no wrong doing with the Secretary of State, his office, and Pro V&V.
- Judges have used the audit in legal cases.

Dear Inspector General McAfee,

We, The Mountain Patriots, are formally requesting that case OIG File No. 22-0023-I is reopened or a new investigation is conducted. Additional information and evidence have been identified which establishes a case for fraud committed by the Secretary of State of Georgia and members of his office.

As I'm about to prove: 1. Dominion Voting Systems voting machines audit did not occur as described by the Secretary of State Raffensperger. Five of the six counties identified by the Secretary of State confirmed that no audit occurred in their county. 2. This same evidence proves that the Georgia audit report was fabricated for the Secretary of State by Pro V&V. 3. A series of fraudulent actions were taken by the Elections Assistance Commission (EAC) to fictitiously illustrate Pro V&V's accreditation. Deception and Dereliction of Duty



September 8, 2020 Secretary Raffensperger announced approximately 1,000 individuals faced investigation for double voting. Nearly three and a half years, Secretary Raffensperger has not investigated or resolved the double voting issues.

November 13, 2020 Dominion Voting Machine Audit by Pro V&V, all is perfect

January 6, 2021 Letter to Congress (not made public) – no fraud in Georgia

February 27, 2021 The board considered 75 cases during its third meeting of the month, sending dozens of them to the attorney general or local district attorneys for prosecution. In acting on more than 300 cases in February, the board demonstrated its intolerance for violations that impact the integrity of elections.



Per Georgia Law

A member of the Secretary of State's office (Fuchs) secretly recorded a phone call with President Trump, they created a public record per Georgia Code § 45-11-1 - Offenses Involving Public Records, Documents, and Other Items. When they altered the recording, they violated §45-11-1, when they attempted to destroy the recording, they again violated § 45-11-1. Per Georgia code §45-11-1, two felonies were committed by the Secretary of State's Office, one in altering the recorded public record and another in destroying it. This recording was identified in the trash on a Secretary of State computer and forwarded on as a public record following a FOIA.

And Mr. Secretary, as I understand it, your office took several steps to ensure the accuracy of the vote count in Georgia, reviewing the vote count in at least three different ways.
