


Mr. Edward #1 US Air Force Vietnam Vet

- Young school teacher dies 09/2020 in Dougherty County
- Dougherty Cancels her ID October, 2020
- October 2022, TWO YEARS after DEATH, a Duplicate ID was created during a Federal Election
- On Aug 2, 2023, the Duplicate ID was cancelled, BUT
- On Aug 2, 2023, the Original ID was reissued on the Voter Roll
- She is Currently an Active Voter




Duplicate IDs Reissued Sec. A.2 Case One

- We used to think Duplicates were an accident
- Nothing could be further from the truth
- This case shows identity theft over four years on one person
- We caught wind when one of her Duplicate IDs that had been previously cancelled showed up in a totally different county with HER driver's license #,HER SSN#, HER birthdate, and a FAKE address and FORGED signature!
- This Identity Theft came through the Dept. of Driver Services as a False Government Document

Peach County Double Votes

- Reg ID 00141199 moved from Bibb to Peach in March 2023 per the Voter Roll
- He had identity theft committed on him Jan 2024 when a Duplicate ID 15198574 was created
- He now has **TWO** Reg IDs
- The SoS files show him double voting on May 8th, 2024 in the Primary

Mr. Edwards, US Army Two Tours in Vietnam



- Mr. Edwards#2, Reg ID 1231783, died in 2014
- Prominent person in Barrow County law enforcement
- Brought in a Duplicate after he died in 2015, with back dated dates, as an inactive voter.
- Activated him in "2016" then made inactive again
- The SoS brought back original ID Aug 2023, as an active voter while cancelling the Duplicate ID.
- Made him inactive, No Contact (What?)
- Disappeared off the Voter Roll with no Cancel.

Felons Sec. A.3 Case One

- There are multiple schemes against Felons
- Case One used to live at 4155 Satellite Blvd, Duluth, GA
- In 2015 he was arrested for Armed Robbery and received a 20-year sentence
- He was cancelled by Gwinnett County in 2017 and the reason was "Felon"
- Apr 2023, he is reissued on VR at **3900** Schatulga Rd, Columbus, GA which is the **jail**.
- May 2023, he moved to **3900 Satellite Blvd**, Duluth, GA



Felons Sec. A.3 Case One - Cont'd

- He was on Gwinnett VR from May 2023 until Aug 2023
- Gwinnett Elector Challenged this person on VR
- Gwinnett Election Supervisor sent a letter on Aug 16, 2023 stating Felon had been in Columbus since Apr 2023 (which wasn't true)
- GARViS Audit History Log no longer has any evidence of being in Gwinnett from May August showing the obvious Fraud.
- The "update" was made on Aug 14, two days before the letter was sent out.



Felons Sec. A.3 Case One - Cont'd

I am writing to acknowledge receipt of your letter dated August 8, 2023, and the attachments.


Manipulation of Official List of Electors

- Back Dating of Registration Dates to have the "appearance" of Registering in time to Vote is criminal intent
- This is a disturbing pattern across 2020, 2022, and the recent 2024 Primary
- In 2020 the deadline to Register to Vote was 10/5/2020.
- We have a 10/25/2020 Voter roll which "should have" all eligible electors
- We compared the 10/25 VR with the 11/22 VR and found **9,300** Reg IDs with a 10/5 Reg Date or before (back dated)
- Of those, 3,700 received credit for voting

- Reg ID 00354852, McBride, DeKalb Fireman and Paramedic
- Deceased: July 12, 2022
- Cancelled: 8/14/2022
- Reissued on Voter Roll: 6/16/2023
- Date Last Contact 6/16/2023 Who's talking to him????
- Moved to Inactive NCOA 12/2023 (Where did he move? He's DEAD)
- Disappeared by 01/2024 w/o Cancel

2020 Unlawful Too Early Ballots

- Absentee ballots could not be requested until 180 days or less before the 2020 General election
- That date was May 6, 2020
- The normal process is for the county elections office to handle this process and reject any ballot request too early
- In 2020, Raffensperger took over the process of ballot requests until some time in mid-September.
- The stated reason was saving \$\$ on a mass mailing which was Sept 18th



2020 Unlawful Too Early Ballots - Cont'd

- Outside the Counties knowledge, 158 of 159 counties accepted ballots too early dating back to January of 2019, many times in large "batches"- before and during COVID
- What human requests a ballot in January of 2019 for a November 2020 election?
- The number of unlawful too early ballot requests turned into235,000+ votes
- How do you hide an unlawful LARGE amount of ballots? A MASS MAILING
- What happened to these ballots?
- Did Raffensperger know COVID was coming? The file suggests so.






Gwinnett Does Not Follow the Law





Deleted and Swapped Vote


- Patrick and Rose lived in Fannin County in 2020
- They like to vote together, in person, on election day
- They checked into the Fire Station Precinct one minute apart on 11/3/2020
- Their voter history and their "My Voter Page" on the Secretary of State website tells a different story
- Patrick "apparently" voted via Raffensperger's Unlawful Too Early Ballots
- He not only didn't ask for a ballot, they didn't mail a ballot, or vote via ballot.
- "If" he had voted via this Fake Ballot, he could have never checked in at the Fire Station.
- His vote was deleted and then swapped for a fake ballot.




Credited Votes on Ballots that were never Received

- Ms. Konke died 9/9/2020
- Bibb County Cancelled her on 9/27/2020 as "Deceased"
- She has in her record one of Raffensperger's unlawful too early requested ballots (requested 4/13/20)

- A Raffensperger Unlawful Too Early Absentee Ballot Request was received on 10/7/2020

• Until our voter rolls are decentralized, the machines are UNPLUGGED, and we go to hand marked, hand counted paper ballots, the Secretary of State's office CAN, HAS and WILL alter an election!
